What is monitoring?

Monitoring is continuous performance tracking against a scheduled timeframe throughout the project's lifetime. Monitoring involves systematic and purposeful collection of on ground information. It is a recurring process to assess project progress and understand delays, diversions, constraints, and effects (intended and unintended) on the stakeholders.

Monitoring helps maintain a project's physical and financial health through real-time tracking and reporting. It is an integral part of any social development project and is crucial to ensure the successful implementation of the activities. Developing a customised monitoring framework is a prerequisite for project implementation and ensuring outcomes and impact.

Common challenges

- Cannot access the real-time data for projects. This impacts all future resource allocation and making informed decisions.
- There is no structured process for sharing updates and insights regarding the projects between the team members and stakeholders. This often leads to misunderstandings and misalignment.

- The human resources working on projects are underutilised due to a lack of clarity in KPIs. This impacts the overall efficiency of the team.
- The budget allocation of projects is not tracked and managed regularly. This could lead to incorrect budget allocation and non-compliance later in the year.
- Administration costs are unusually high. Due to this, the available budget for project activities and desired outcomes often gets compromised.
